#### NOTES TO INCOME AND EXPENDITURE ACCOUNT

#### 1. GENERAL

Yan Chai Hospital (the "Charity") is a charitable organisation established in Hong Kong by virtue of the Yan Chai Hospital Ordinance (Chapter 1106). The Charity engaged in the provision of charitable services including but not limited to education, nursery, recreation and sports, medical, social welfare and emergency assistance relief services in Hong Kong.

The Raffle Ticket Sale 2024, namely Yan Chai Charity Fortnight 2024 - Yan Chai Charity Raffle (the "Event"), is a charitable event organised by the Board of Directors of the Charity. The purpose of the Event is to raise charitable funds in aid of Yan Chai various charitable services.

The Event has been held during the period from 7th September, 2024 to 31st October, 2024 in specified locations as approved by the Home Affairs Department of the Government of the Hong Kong Special Administrative Region.

### 2. PRINCIPAL ACCOUNTING POLICIES

### Basis of preparation

The income and expenditure account has been prepared using the historical cost basis of accounting.

#### Income recognition

Sale of raffle tickets is recognised on cash basis.

#### 3. INCOME TAX

As the Charity is registered as a charitable organisation under section 88 of the Inland Revenue Ordinance, the surplus of the Event is exempted from Hong Kong Profits Tax.
